## School Admission Appeals Timetable 1 March 2021 – 28 February 2022

Admission appeals are administered in accordance with the requirements of the 2012 School sion Appeals Code issued by the Department for Education. Parents whose admission tion is refused will have the legal right to appeal that decision. To lodge an appeal, complete urn the Appeal Form which can be downloaded from the School website or requested from the Office.

On receipt of the completed Appeal Form, the Admission Authority will arrange for an appeal hearing to take place before an independent Appeal Panel. The timetable differs depending on when the appeal is lodged and whether it relates to an application to start at the school for the first time in September 2019 or to join the School during the academic year.

### Starting School in September 2021 – For appeals lodged after 17 May 2021

It may be possible for appeals lodged after 17 May 2021 to take place at the same time as those lodged before this deadline, <u>providing</u> there is sufficient time to make the appropriate arrangements. Otherwise, appeals lodged after 17 May 2021 will be heard within **30 school days** of receipt of the appeal form

#### Lodging an appeal relating to an In-Year admission application decision

An appeal may be lodged within **30 school days** of the admission decision being issued. An appeal hearing will be scheduled to take place within **30 school days** of receipt of the appeal form
